Mini Township at Khasra No.-675, 676, 677, 678, 680 & 692, Village-Madiaon, Tehsil-Bakshi Ka Talab, Lucknow., Shri Atul Kumar Saxena, M/s ORO REAL INFRA LLP, File No. 6628/Proposal No. SIA/UP/MIN/233935/2021

SEIAA noted that the above project was taken in its 581st meeting in which SEIAA opined that project proponent should submit LDA approved map, detail of STP discharge points and its location, solid waste generation and segregated discharge quantity and bioorganic converter and its detail. The project proponent has submitted his reply vide letter dated 06.06.2022. After reviewing the reply SEIAA agreed with the recommendations of the 632nd SEAC meeting to grant the prior Environmental Clearance to the proposed project along with all the general and specific conditions as suggested by the SEAC. In addition to the conditions imposed by SEAC the SEIAA added following additional specific conditions:-

- 1- The project proponent shall submit within the next 3 months the details of solar power plant and solar electrification details within the project.
- 2- The project proponent shall ensure to plant broad leaf trees and their maintenance. The CPCB guidelines in this regard shall be followed.
- 3- The project proponent shall submit within the next 3 months the details on quantification of year wise CER activities along with cost and other details. CER activities must not be less 2% of the project cost. The CER activities should be related to mitigation of Environmental Pollution and awareness for the same.
- 4- The project proponent shall submit within the next 3 months the details of estimated construction waste generated during the construction period and its management plan.

- 5- The project proponent shall submit within the next 3 months the details of segregation plan of MSW.
- 6- The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharge.
- 7- Under any circumstances untreated sewage shall not be discharged to municipal sewer line.
- 8- The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition Waste Management Rules.
- 9- The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
- 10- A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.

- 9- The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.
- 10- A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain forest clearance and permission of Central and State Government as per the provisions of Forest (conservation) Act, 1980 and submit before the start of work.

- 3. Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 02/10/2027 to the Board.
- 4. Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution)Act, 1981 from the Board.
- 5. It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
- 6. Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

Specific Conditions:

- 1. This Consent to Establish is being granted M/s ORO Real Infra LLP at Khasra No. 675, 676, 677, 678, 680 & 692, Vill-Madiaon, Tehsil-Bakshi Ka Talab, District- Lucknow having Total plot area 63,566.87 Square Meter and Built-up area shall be 35,579.87 Square Meter for construction of Group Housing, E.W.S./L.I.G., School etc as proposed.
- 2. This CTE is valid for only the Township Project. In Case of any change, enhancement, any construction etc. PP should obtain again Consent to establishment (CTE) certificate from the Board separately.
- 3. The project proponent shall ensure to provide the proper exhaust from roof level along with acoustic enclosures on DG sets (capacity of 600 KVA, 64X3 and 32 KVA) as per prescribed standards.
- 4. The PP shall ensure to install STP of capacity 400 KLD for treatment of domestic sewage and treated effluent shall be used for irrigation in green belt of the premises and rest shall be discharged in to drain as per the norms specified in Environment (Protection) Act, 1986.
- 5. The PP shall ensure to establish Miyawaki forest, so that entire treated effluent may be used for irrigation as per the GO no. 1011/81-7-2021-09(rit)/2016 dated 13.10.2021 of Deptt. of Environment, forest and Climate Change.
- 6. The Order issued by Hon'ble Courts/Hon'ble NGT, MoEF & CC, Central Pollution Control Board, U.P. Pollution Control Board shall be complied with.
- 7. Project shall not start gaseous emission & sewage generation without obtaining CTO (Air and Water) from the Board.
- 8. The PP shall obtain NOC from UP Ground Water Department for abstraction of ground water within 03 months and submit in the Board.
- 9. The dust emission from the construction sites shall be completely controlled and all precautions will be taken in that behalf.
- 10. All approach roads & in campus roads should be sprinkled with water to suppress the dust emission.
- 11. The project shall ensure to put tarpaulin scaffolding around the area of construction and the building for effective and efficient control of dust emission generated during construction of the project.
- 12. Storage of any construction material particularly sand shall not be done on any space outside the project area.
- 13. The project shall comply with the provisions of Construction and Demolition Waste Management Rules, 2016.
- 14. The construction material of any kind stored on site shall be fully covered in all respect so that it does not disperse in the air in any form. The dust emission from the construction sites shall be completely controlled and all precautions will be taken in that behalf.
- 15. All the construction material & debris shall be carried in trucks or vehicles which are fully covered and protected so as to ensure that the construction debris or construction material does not get dispersed into the air or atmosphere in any form whatsoever.
- 16. The PP shall ensure to install Organic Waste Convertor for bio degradable waste in its premises before completion of project.
- 17. The project shall ensure to provide the proper Wind breaking wall constructed around the construction site.
- 18. The PTZ web cameras shall be installed on STP outlet. Online continuous monitoring system shall be installed for monitoring of treated water and provide the URL ID and password to the Board.

- 19. In case of installation of hotmix/ready mix plant, the prior permission shall be obtained from the Board.
- 20. Fixing of sprinklers and creation of green air barriers shall be done to control fugitive dust emission and improve environment. Compulsory use of wet jet in grinding and stone cutting shall be practiced.
- 21. The project shall comply with the provisions of Environment (Protection) Act 1986, Water (Prevention and Control of Pollution) Act, 1974 as amended, Air (Prevention and Control of Pollution) Act, 1981 as amended, Plastic Waste Management Rules 2016, E- Waste (Management) Rules 2016, Solid Waste Management Rules 2016 & Hazardous and other Waste (Management and Transboundary Movement) Rules 2016 (Whichever is applicable).
- 22. Project shall submit a bank guarantee of Rs. 10.0 Lakhs within 15 days for compliance of the above conditions no 1 to 21.
