NATURE OF BOOKING

1.2 The provisional booking do not convey in favour of purchaser any right, title of interest of whatsoever nature unless and until require documents such as Sale Agreement/Sale Deed/Allotment Letter etc are executed.

2. REGISTRATION & OTHER CHARGES

2.1 Registration charges, Stamp Duty and incidental expenses there to as applicable at the time of registration shall be extra and is to be borne by the purchaser.

1.2 Other Statutory taxes as applicable from time to shall be extra and are to be borne by the purchaser.

3. MODE OF PAYMENT

3.1 All payment from outstation locations are to be paid through DEMAND DRAFTS only. Demand Drafts/Local Cheques are to be made payable to Aarohi Constructions Pvt. Ltd.

4. DELAYED PAYMENTS

4.1 Interest @ 2% per month shall be charged on all delayed payments of installments.

5. LOANS
