1. The balance Rs. 1,60,000 along with 7.50% interest will be deposited in 80 quarterly equal installment. The amount of each installment is Rs. 3878 (Three Thousand Eight Hundred Seventy Eight) including interest and due date of first installment is 31.07.09

2. If the amounts payable to Ghaziabad Development Authority are not paid within the prescribed time limit, Penal interest at the rate of 10.50% per annum shall be payable along with the payable amounts. If the payment is not made within three months from due date along with penal interest, if any, the allotment shall be treated cancelled without notice.

3. Grace period of one month shall be given for payment of Allotment amount/installment after the due date. However if any previous amount of installment stands unpaid on the due date, no grace period will be admissible on the current Installment. In case payment is made after the grace period, penal interest shall be payable from the original due date of payment.

4. Possession of flat shall be given to allottee after payment of 20% amount of final cost. The Possession of Allotted House shall be given approximately after 31-08-09. 10% lease rent amount of Land Cost shall also be deposited & registered agreement shall be executed before Possession by the allottee at his/her own expenses.
