That the vendor of the first part have represented and confirmed that the said property and the land underneath it, which is subject matter of present sale deed is free from all sorts of encumbrances, such as lien, prior agreement to sale, or sale to any other person, mortgage,gift, notice, notification dispute litigations etc. and the vendor of the first part are fully authorized and have legal capacity to transfer the same in favour of the vendee of the second part.

That the vendor of the first part have represented and confirmed that in case the second part are put to any monetary loss, harm or injury of any part of the property on account of any legal defect in the title of the vendor of the first part or on account of any representations made by the vendor found to be untrue or on account of suppression of any material facts pertaining to the title of the said property, the vendor of the first part shall be indemnified the vendee of the second part in respect of any such loss.
- 7. That the stamp duty and registration charges in respect of the sale deed have been paid and borne by the vendee of the second part.
