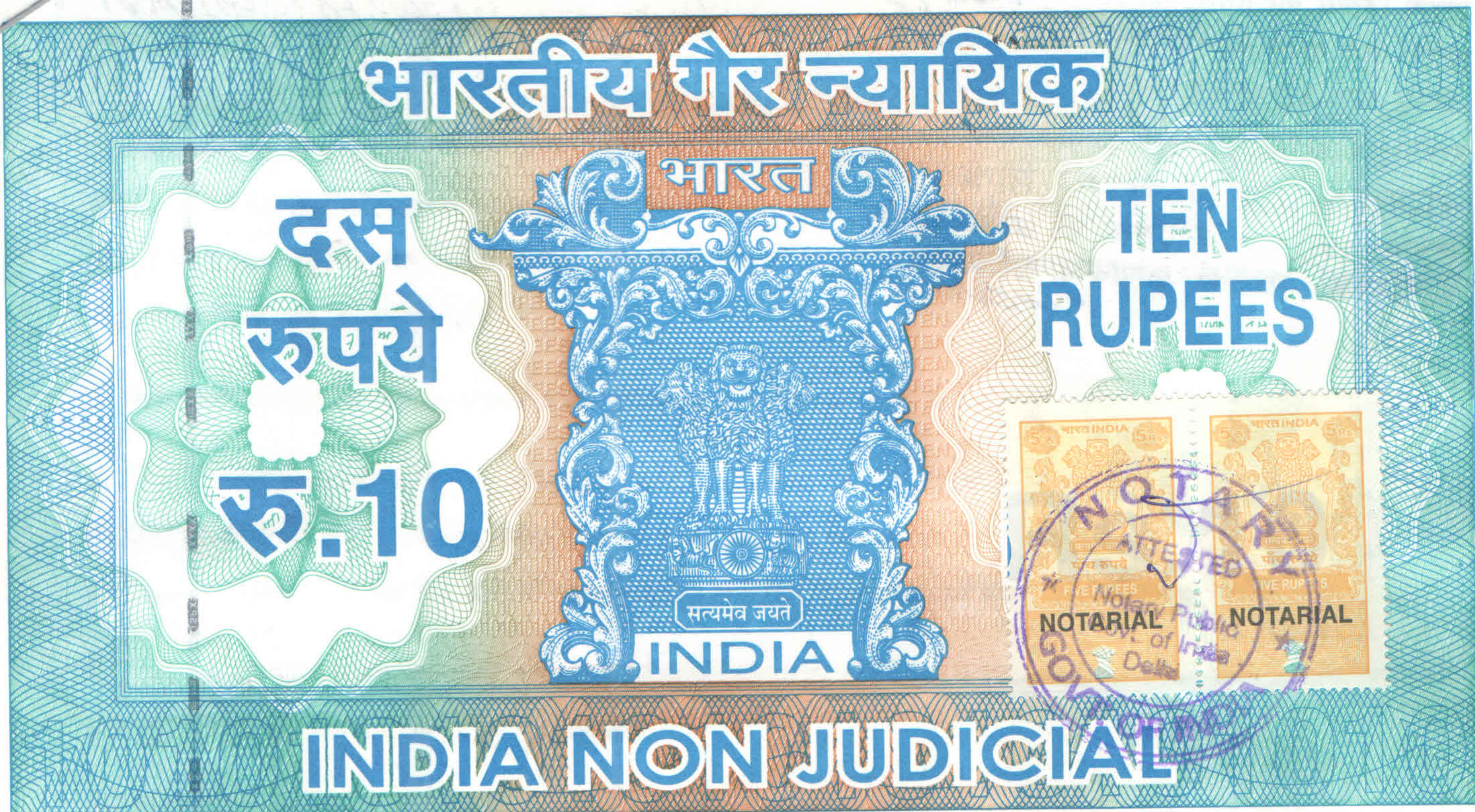

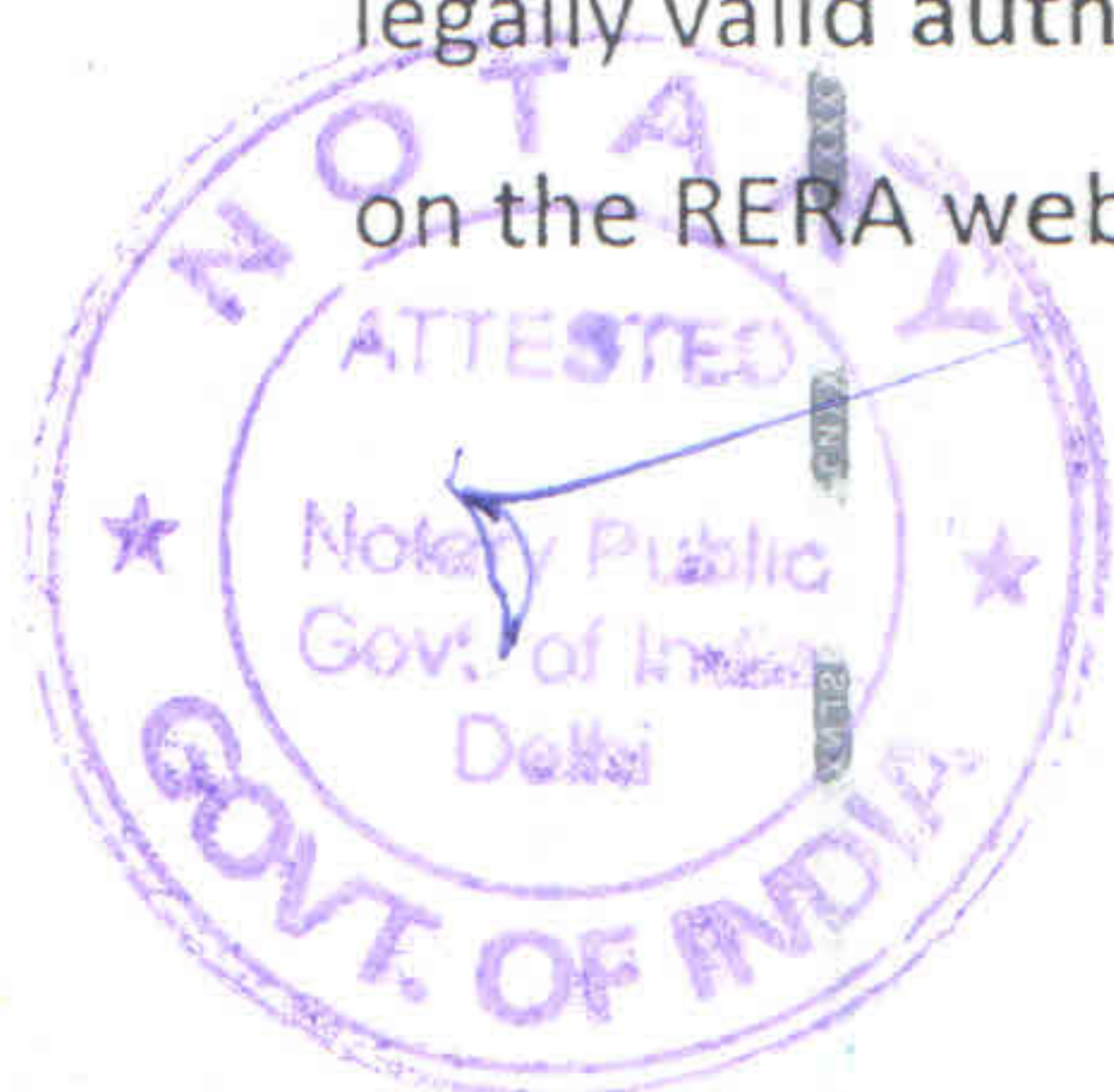

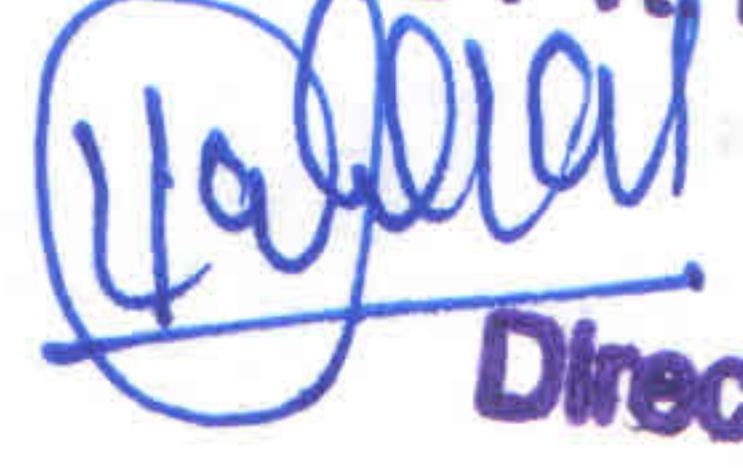
Affidavit cum Declaration

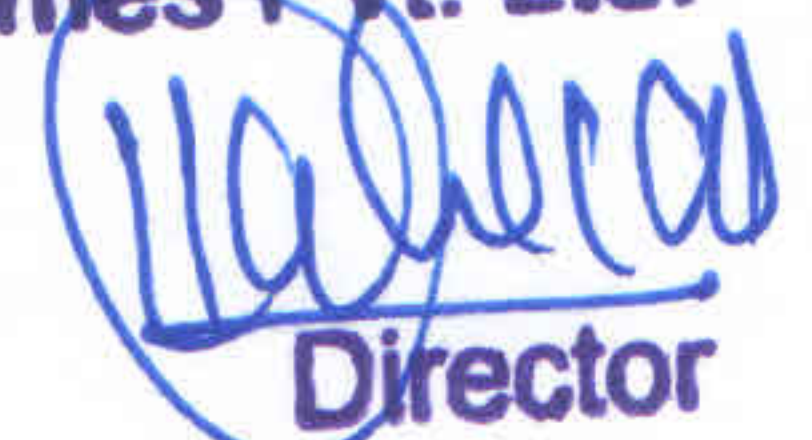
