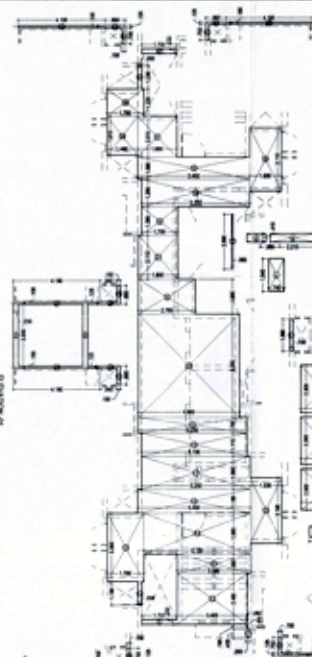


STILT FLOOR PLAN,

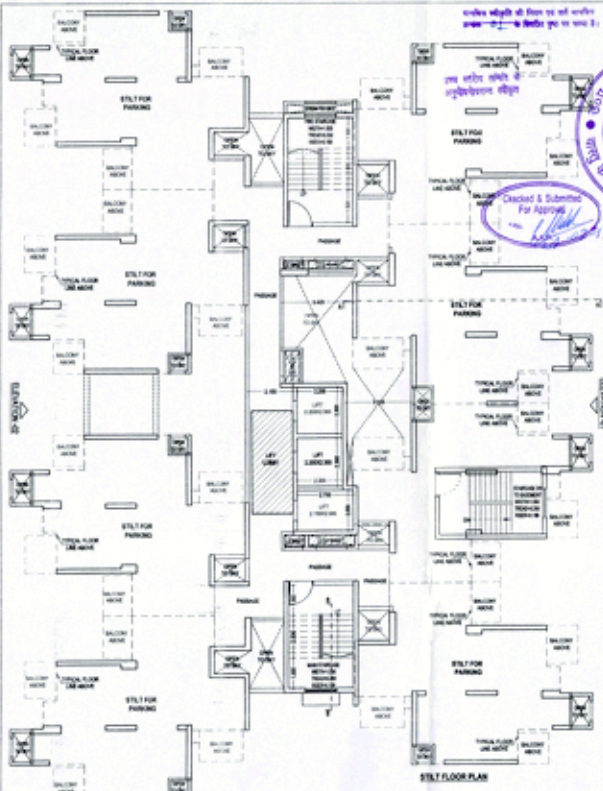

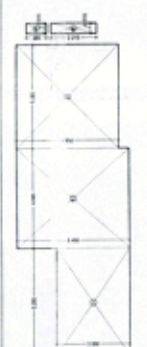

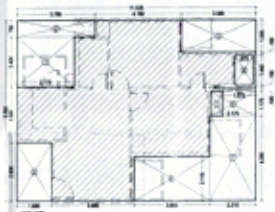
### STYL FLOOR PLAN
