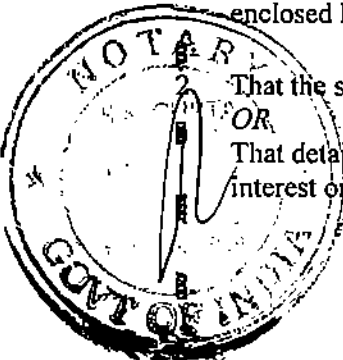

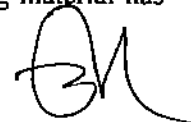
3. That the time period within which the project shall be completed by me/promoter is 31/01/2024
4.
