This office has no objection to the construction of the proposed Construction of Group Housing Firsts by Mrs Aims Max Gardenia Developers (P) Ltd., herein after referred to as the applicant(s) at location Eco City, Sector 75, Noida, Gautam Bidth Nagar, (Co-ordinates: 28, 34, 40, N, 77, 22, 55, E.) for a height of <u>90.00 Mts.</u> (in figure) Ninety Decimal Zero Meters. (in words) above ground level so that the top of the proposed structure when erocted shall not exceed <u>200.00 Mts.</u> (site elevation)

that the top of the proposed structure when encoded shall not exceed 200.00 Mts. (site elevation) plus(+)<u>90.00 Mts.</u> (height of structure) = <u>290.00 Mts.</u> above mean sea level. This no objection certificate is being issued on the express understanding that the site elevation (height above mean sea level) viz <u>200.00 Mts.</u> relative location of the proposed **building/structure & is distances and bearings from ARP/ Runway ends, as tendered by the applicant(s)** are correct. If, however, at any stage it is established that the said data as tendered & which could adversely effect aircraft operations, the structure or part(s) thereof in respect of which this 'No Objection Certificate' is being issued will have to be demolished at his own cost as may be directed by the Airports outporting in the first and the enterplane activiser in his (their own interest to verify the elevation Authority of India. The Applicant(s) are therefore advised in his /their own interest to verify the elevation

and other data furnished for the site, before embarking on the proposed construction. The issue of this 'NOC' is further subject to the provisions of Section 9-A of the Indian Arcraft Act, 1934 and those of any holifications issued there under from time to time and under which also tho applicant may be called upon by the Airports Authority of India (National Airports Division) to demoksh in whole or in part the structure now being authorized vide this 'No Objection Certificate'

The use of electric fire or oil fired furned is obligatory. This certificate is valid for a period of five years from the date of issue. If the building fetracture /chimney is not constructed & completed within the above mentioned period of <u>five years</u>, you will be required to obtain a fresh 'No Objection Certificate' from the Arports Authority of India(National Ariports Division) and/or the General Manager, Aerodiomes, Northern Region. The date of completion of the beilding? structure/chimney should be intimated to the Airports Authority of India and/or the General

Manager, Aerodromes, Horthern Region. No light or a combination of lights which by reason of its intensity, configuration or colour may cause confusion with the asronautical ground lights of the Alrport shall be installed at the site at any time during or after the construction of the building

Day & Night markings with secondary power supply may be provided as per ICAO Standard. The permissible top elevabor/height includes height for superstructures ( eq. Wireless, TV addenses, munifies, BR machine room, overhead water tank cooling lowers etc.)\* NOTES THE SITE IS EXAMINED W.R.T.IGLARPORT AND SAFDARJUNG ARPORT ONLY.
