I, Anand Kumar Srivastava, Director of the Promoter, whose registered office is situated at S-16, Second Floor, Eldeco Station 1, Site No. 1, Sector 12, Faridabad, Haryana-121007, which is developing a proposed Group Housing project on land admeasuring 20235 sq. mt. namely "Eldeco Whispers of Wonder" situated at GH-01C/1, Sector-22D, Uttar Pradesh ("Project") hereby solemnly declare, undertake and state as under:

1. That the Promoter has a legal title to the Project land on which the development of the proposed project.
2. That the said land is free from all encumbrances.
3. That the time period within which the Project shall be completed by the Promoter is **17<sup>th</sup> July, 2030**
4. That seventy percent of the amounts realised by Promoter for the Project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only that purpose.
5. That the amounts from the separate account, to cover the cost of the Project shall be withdrawn in proportion to the percentage of completion of the Project.
6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the Project.
7. That Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.
8. That Promoter shall take all the pending approvals on time, from the competent authorities.
9. That Promoter have/has furnished such other documents as have been prescribed by the Rules and regulations made under the Act.
10. That Promoter shall not discriminate against any allottee at time of allotment of any apartment, plot or building; as such case may be, on any grounds.


