I, Ajeet Kumar do hereby solemnly declare, undertake and state as under:

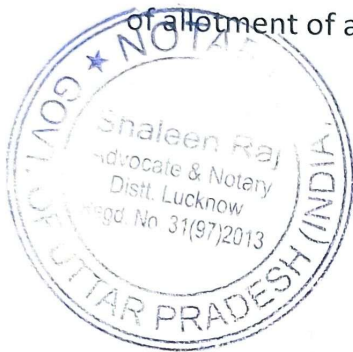
1. That the promoter have a legal title to the land on which the development of the project is proposed
