A legally valid authentication of title of such land along with an authentication copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

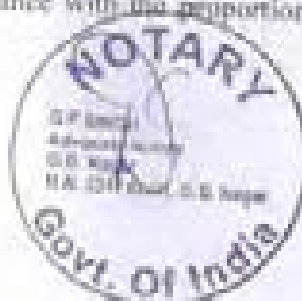
2. That the said land is leasehold land from GNIDA. The lease deed is uploaded on the site and all the terms and conditions are mentioned in the lease deed. We have taken a construction finance of Rs. 60 cr. from LIC Housing Finance Limited.

3. That the time period within the project shall be completed by the promoter is 31.03.2019.

4. That seventy per cent of the amounts realised by the promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

6. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That the promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
