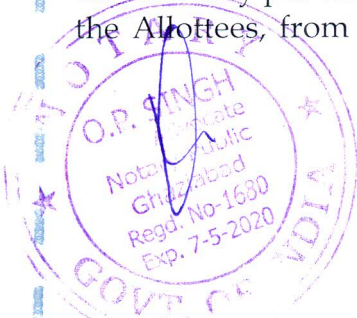

AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of Mr. Kushagr Ansal S/o Shri Deepak Ansal, R/o 82, Jor Bagh, New Delhi - 110003, Wholetime Director and CEO of M/s Ansal Housing & Construction Ltd. Promoter of the ongoing project **"ANSALS PALM COUNTY, MEERUT PLOT, PHASE-I**, duly authorized by the promoter of the proposed project, vide its authorization dated 29.05.2017;

I, Kushagr Ansal authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. That the land title is in favour of M/s Fascinate marketing pvt ltd., M/s Kamal consultants pvt. ltd., M/s Granth builders and developers pvt ltd., M/s Astonish marketing pvt ltd., S.S. Infraventures pvt ltd., M/s V.S. builders & developers., M/s Andri builder and developers pvt.ltd., And M/s Ansal Housing & Construction Ltd through various registered sale deeds. The project **"ANSALS PALM COUNTY, MEERUT PLOT, PHASE-I**, which is a Residential project, is being developed by M/s Ansal Housing & Construction Ltd.
2. That there is no encumbrance on the said project.
3. That the time period within which the project shall be completed by the promoter is 31/03/2020.
4. That seventy per cent of the amounts realized by me for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be

maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That the promoter shall take all the pending approvals on time, from the competent authorities.
9. That the promoter have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder and shall furnish any other further documents as and when directed by the authority.
10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
