discrepancies, the same to be brought to be notice of engineer /architect and same to be resolved prior to execution of work.

8.This drawing is valid subject to all mandatory approvals for the same are taken from relevant approving authorities by the client / liaison architect

9.Lift door openings to be co-ordinate with lift manufacturer's approved drawings.

10.All railings/grills to be fixed as per fabricators/structural consultants details. In case the details are provided by fabricators/contractors the structural consultant approval will need to be taken for

the structural worthiness. 11.Insulation over terrace roof to be as per specifications. As per mep and client requirements 12. Sleeves to be left in beams for all sprinkler pipes, A.C. chilled water pipes, electrical conduits, etc.


13.All MEP cut-outs to be sealed after laying of services (except on external service ledges) as per
