AFFIDAVIT

Avas Evam Vikas Parishad, Development Authority, UP RERA etc.**

2. **That** the Society undertakes to confirm that after getting it executed as per the statutory requirements of the Societies Registration Act, 1860, we shall submit the modified copy of the Memorandum of Association within three months from the date of this Affidavit.






