Rajeev Kumar Arora (Director) in M.R Proview Realtech Pvt Ltd Project (Delhi 99 EWS & MIG) duly authorized by the director of DELHI 99 EWS & LIG Project do herby solemnly declare, undertake and state as under:

- 1. That M.R Proview Realtech Pvt Ltd has a legal title / Joint development agreement to the land on which the development of the project is proposed.
- 2. That the time period within which the project shall be completed by Director's of M.R. Proview Realtech Pvt Ltd is 36 Months.
- 3. That seventy percent of the amount realized by Director's of M.R Proview Realtech Pvt Ltd. For the real estate project DELHI 99 EWS & LIG from the allottees, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for the purpose.

Shall get the accounts audited within six months after end of every financial year by a charted accountant in practice, and shall produce a statement of accounts duly certified and signed by such charted accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawn has been in compliance with the proportion to the percentage of completion of the project.
