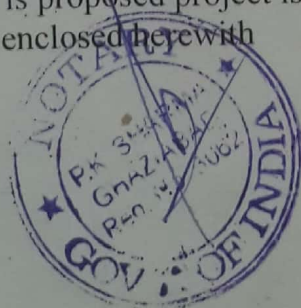

I, Vikas Tyagi, promoter of Elly Realcon Private Limited do hereby solemnly declare, undertake and state as under:

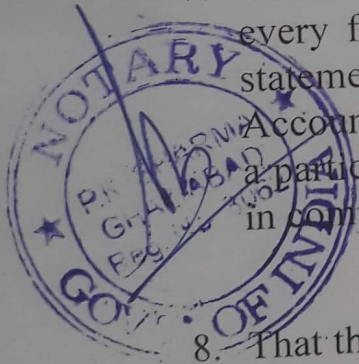
1. That, the promoter has a legal title to the land on which the development of the project is proposed project is carried out and an authenticated copy of the title such land is enclosed herewith

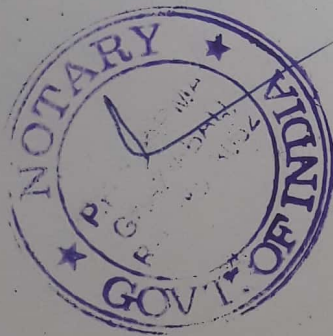
