



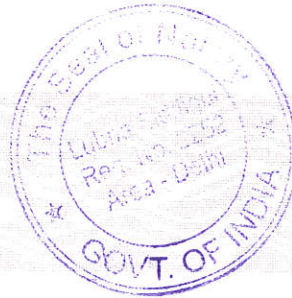

8. That Promoter shall complete all the statutory requirements of obtaining NOC's for approval of the project and shall submit the same to competent authority for approval on time.
