AFFIDAVIT CUM DECLARATION

I. Saurabh Mohindru, S/o Mr. S K Mohindru, Authorised signatory of M/s AR Landcraft LLP, a limited liability partnership registered under the provisions of the Limited Liability Partnership Act, 2008, having its registered office at 3rd Floor, UM House, Tower A, Plot No. 35, Sector - 44, Gurgaon, Haryana, (hereinafter referred to as "Promoter") do hereby solemnly swear, declare, undertake and state as under:

- That I am the Authorised signatory of the Promoter LLP and are duly competent and authorised 1. to depose the present affidavit.
- That the Promoter is developing Presidential Villas (hereinafter referred to as "Project"), 2. forming part of larger township "Godrej Golf Links" to be set up at plot no. REP-1, Sector 27, Greater Noida, District- Gautam Buddha Nagar, State- Uttar Pradesh.
- That the Promoter has a legal title over the land on which the development of the Project is 3. proposed.
- That the said land has been mortgaged in favour of ICICI Bank Limited to secure a construction 4. finance facility of Rs. 2,250.0 million (Rupees Two Thousand Two Hundred and Fifty Million Only) availed by the Promoter.
- That the time period within which the Project shall be completed by the Promoter is 30.09.2023. 5.
- That 70% (seventy per cent) of the amounts realized by the Promoter for the real estate Project 6. from the allottees, from time to time, shall be deposited in a separate account to be maintained



in a scheduled bank to cover the cost of construction and the land cost and the said amount shall be used only for that purpose.

- 7. That the amounts from the separate account, to cover the cost of the Project, shall be withdrawn in proportion to the percentage of completion of the Project.
- 8. That the amounts from the separate account shall be withdrawn only after it is certified by an engineer, an architect and a practicing chartered accountant, that the withdrawal is in proportion to the percentage of completion of the Project.
- That the Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular Project have been utilised for the Project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Project.
- 10. That the Promoter shall take all the pending approvals on time, from the competent authorities.
- That the Promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- That the Promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
