Affidavit cum Declaration

Affidavit cum Declaration of Arpit Yadav (Partner) duly authorized by the promoter "A & P LUCKNOW CONSTRUCTIONS" of the proposed project "MANSHA PLAZA".

- I, Arpit Yadav, duly authorized by the promoter of the proposed project do here by solemnly declare, undertake and state as under:
- 1. That the promoter has a legal title to the land on which the development of the project is proposed.
- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by me/promoter is 31.08.2025.
- 4. That seventy percent of the amounts realized by me/promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.
- 6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the with drawal is in proportion to the percentage of completion of the project.

- 7. That promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
 - That promoter shall take all the pending approvals on time, from the competent authorities.
 - That promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
 - 10. That promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
