- 1. That promoter of the proposed project has a legal title to the land on which the development of the project proposed is to be carried out

AND

legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith

- 2. That the said land is free from all encumbrances.
- 3. That the time period within which the project shall be completed by the promoter is $\frac{5 \text{ years}}{12/25}$
- 4. That seventy per cent of the amounts realized by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in ascheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

That the promoter shall get the accounts audited within six months after the end of everyfinancial year by a chartered accountant in practice, and shall produce a statement of accountsduly certified and signed by such chartered accountant and it shall be verified during the audithat the amounts collected for a particular project have been utilized for the project and thewithdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That the promoter shall take all the pending approvals on time, from the competent authorit

9. That the promoter has furnished, such other documents as have been prescribed and and regulations made under the Act.

10. That the promoter shall not discriminate against any allottee at the time of allotment of anyapartment, plot or building, as the case may be, on any grounds.
