8. That /promoter shall take all the pending approvals on time, from the competent authorities,
9. That I / promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act
10. That I / promoter shall not discriminate against any allottee at the time of allotment of any shops or offices, as the case may be, on any grounds.
