For registration of new project in UP RERA, it is necessary to clarify some facts. In relation to the said project, the promoter had applied for the map in 2015, on this application the Greater Industrial Development Authority approved the building plan in February 2018. The promoter started work on the project after completing all the necessary procedures, but after some time the work on the project got stopped due to GNIDA has cancelled the allotment of allotted plot. Copy of the cancellation letter issued by GNIDA as **annexure -1(Colly)**.

1. In the promoter's details, the audited balance sheet for the preceding year and the ITRs for the preceding three years are not uploaded. Also, the website mentioned on the promoter's portal is not functional.

- We have uploaded the audited balance sheet of preceding year and ITR of last three years and a copy of the same is attached. Copy of the Balance sheet and ITRs are annexed as annexure -2(Colly).

2. The uploaded map was approved on 15-02-2018 for 5 years. Hence the validity of the map expired on 14-02-2023. The validity of the map through the sanction letter was extended till 26-07-2023 which has also passed.

- We had submitted a request to the GNIDA through vide letter dated 16-07-2023, in which we had requested to grant additional time for our approved sanction plan treating the said time period(of project land, from cancellation to restoration) as zero. On which the GNIDA issued a letter dated 04-09-2023 and provided additional time for the map of the project, whose additional time will be 1 year 4 months. A copy of the valid sanctioned plan along with GNIDA Letter dated 04-09-2023 are annexed as annexure – 3 (Colly).
- That the Promoter affirms that the valid sanctioned plan approved by the GNIDA (Greater Noida Industrial Development Authority). To which the authority has provided additional time of 1 year and 4 months on the basis of force majeure

through its letter dated 4/9/2023. In which does not include the time of Covid-19 pandemic.

- We would like to clarify here that the allotted land of the said project was cancelled by the GNIDA on 22-04-2022. Whose restoration was done on 26-07-2023. As we have also mentioned in the para 1.

3. The development work brief description is neither explained in detail nor quantified.
