

- 1 That I have a legal title to the land on which the development of the project is proposed.

- 3 That the time period within which the project shall be completed by the promoter is August 2020.
- That seventy Percent of the amounts realised by promoter for the estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a schedule bank to cover the cost of construction and the land cost and shall be used only for that purpose.
- That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project.

- That I shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of account duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particulars project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

- 9 That I have furnished such other documents as have been prescribed by the rule and regulation made under the Act.
- That I shall not discriminate against any allotee at the time of allotment of any apartment, plot or building, as the case may be, on any ground.
