THIS INDENTURE made the nineteenth day of October, One thousand nine hundred forty three between the Governor of the United Provinces (hereinafter called the Vendor) of the one part and Mr. Ganga Narain Khattri son of Mr. Chhanga Lal Khattri resident of premises No. 3/23 Ariyanagar, Campora City (hereinafter called the Purchaser) of the other part;

WHEREAS the hereditament and the premises described in the schedule hereto annexed had been acquired for the D.N.W. Railway under Government Notification No. 262/NIII-233 dated 31-1-1921 under the provisions of the Land Acquisition Act (Act I of 1894)


AND WHEREAS THE said land being no longer required by the said Railway was offered to the original owners thereof who refused to take it back;

NOW THIS INDENTURE WITNESSETH THAT in consideration of the sum of Rs. 1,900/- paid by the Purchaser to the Vendor (the receipt whereof the Vendor hereby acknowledges) the Vendor hereby transfers unto the Purchaser ALL his right title and interest of and in the hereditaments and premises described in the schedule hereto together with all rights easements and appurtenances to the said premises belonging provided that the purchaser shall not

by these presents acquire any right to public roads, public drains, road side trees, water pipes (if any) on or under the said premises and Excepting and reserving to the Vendor all mines and minerals of whatever nature lying in and under the said premises together with full liberty at all times for the vendor, his agents and workmen to enter upon all or any part of the said premises to tend or remove the said trees and pipes and drains and to search for and get merchantable and carry away the said mines and minerals under or upon the said premises or any adjoining lands of the Vendor and to let down the surface of all or any part of the said premises and any buildings now or hereafter to be erected thereon making fair compensation to the purchaser for damage done to him thereby. TO HAVE AND TO HOLD THAT said premises UNTO AND TO THE USE of the Purchaser subject nevertheless to the payment of land revenue, or other impositions payable or which may become lawfully payable in respect of the said premises and to all public rights or easements affecting the same AND the Vendor doth hereby covenant with the Purchaser that he has not done anything or suffered anything to be done whereby the said premises are in any way encumbered or affected AND FURTHER that the Vendor shall and will from time to time and at all times hereafter at the request and cost of the Purchaser do and
