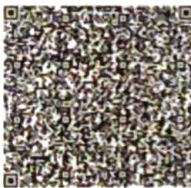

4. 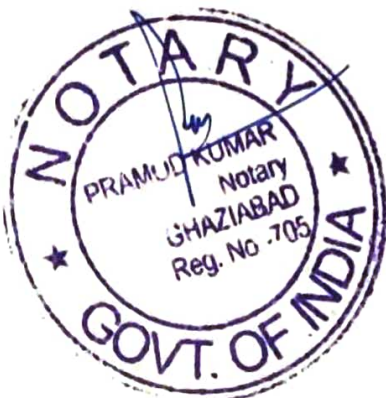
