Whereas the property situate at village Rastampur, Tappa Haveli, Pergara Haveli, Tahsil Sadar, Gorakhpur, and more particularly described in the Schedule hereunder written is a Composite property within the meaning of the said expression in the said Act.

And Whereas the Purchaser has  $\frac{9}{16}$  share share in the said property and the remaining  $\frac{7}{16}$  share being in evacuee interest therein is vested in the Custodian.


