2. The Project is located in Ghaziabad which comes under NCR and the RERA designated Bank Account Branch is conveniently located for the Project. The Bank Accounts are opened in Delhi due to ease of operations as our previous bank accounts are held in the same bank. In today’s digital world all the banks have resorted to online banking and provide several other facilities to ease the banking operations to distant account holders including banking at any branches.

The Three Bank Accounts are as mentioned below:


