- NOTE- Payment should be done within 7 days of completion of every stage i.e.DPC, Lintel, Slab, Plaster, Finishing. In case of delayed in payment theorists work willsuppose to be delayed.
- NOTE If there is fluctuation in material price 5% rate increment will be considered.
- NOTE- The advance amount is non-refundable in case the client wants to cancel after allotment.
- NOTE- Area outside of slab will be under future consideration for the settlement of additional payment from client if required.
- NOTE- Cutting , Filling and Leveling of soil will be in client's scope.

- 8- The demand of Post datedcheque (PDC) against each step should be submitted on time by client.
- 9- Initially Post datedCheque (PDC) required before dumping of material. And following enclosure is required with work order-

 - Approved Government Authority Letter.
- 10- If there is delayed in clearance of bill within seven days additionally 2% of total bill amount will be charged for each month from client.
